A joint enhancing relationship between the disability movement and People Affected by Leprosy seminar was organized by APAL and DPI on 13-02-20 at U S I, New Delhi. 40 leprosy affected people from Delhi and Haryana & 8 people from disability movement participated in the seminar.

Mr. Arman Ali, Executive Director, NCPEDP delivered welcome address and Dr. Vineeta Shankar, Executive Director SILF has presented an overview of Leprosy. Mr. Venu Gopal – Vice President APAL & Mr. Uday Thakar- Advisor APAL addressed the seminar on Leprosy and APAL activities.

After self introduction by participants, Mr. S. N. Tyagi and Mr. Girdhari Lal explained about the present status of Leprosy Affected People in Haryana and Delhi. Mr. Rajiv Rathuri informed about RPWD Act and benefits for leprosy affected people. Mr. Dhawani Mehta, Vidhi Centre for legal policy explained about legislative framework around Leprosy.

Ms. Nikita Sara, TLM informed about livelihood and employment opportunities for people affected by leprosy. Mr. Pankaj Sinha explained about the Supreme Court directions for the empowerment of Leprosy Affected People.

3. Key findings which are important for SHF work

- b. APAL to organizing more coordinated activities with other disabled sectors like DPI & NCPEDP.
- c. Regular meeting of youth leader & women empowerment programmes should be budgeted and organized.
- d. To form women empowerment among colony women

4. Difficulties/Challenges you faced during the period

Difficulties

- 1. Weak communication between stake holders
- 2. Needs of each states are different and hence to develop common proposal for all states becomes difficult.
- 3. It is also very difficult to explain the tangible results of the projects to the donor agency. **Challenges:**
- 1. During the period under review the main challenge communication and follow up work in the different state
- 2. Identity issues for getting social entitlements. Inability to seek or maintain employment or volunteering.
