On  $2^{\rm nd}$  April 2025, APAL's President, Maya Ranavare, participated in the Global Disability Summit 2025 in Berlin, representing persons affected by leprosy on the global stage. Her participation was sponsored and supported by GLRA India.

On 3rd April 2025, the APAL State Committee in Haryana, in collaboration with the Red Cross Society, organized a successful eye check-up camp at the Rohtak Kusht Ashram. Mr. Sanjay Miglani, Chairman of the Red Cross Society, Chandigarh, led the initiative. The primary goal of the camp was to provide essential eye care services to residents of the Kusht Ashram, most of whom are persons affected by leprosy, as well as to extend the service to the general public in the surrounding area.

Nearly 150 individuals actively participated in the event, availing themselves of the eye screening services. The medical team from the Civil Hospital, including Dr. Dinesh Kumar and Dr. K.S. Sharma, played a crucial role in conducting the eye examinations and offering expert advice to the attendees. Their contribution ensured that participants received timely and professional healthcare services.

Key members from the Red Cross Society also extended their support to make the event a success. State Committee of the Association of People Affected by Leprosy (APAL) in Jharkhand conducted a field visit

On 3rd April 2025, the State Committee of the Association of People Affected by Leprosy (APAL) in Jharkhand conducted a field visit to Mahatma Gandhi Cast Colony in Baljoria, Dhanbad and Prem Nagar Leprosy Colony in Saharpura, Sindri. The visit was led by Representative Madhusudan Tiwari, with the core objective of understanding the ground-level issues being faced by the leprosy-affected residents and evaluating the effectiveness of ongoing government welfare schemes.

A significant focus during the visit was placed on the Pradhan Mantri Awas Yojana (PMAY), a central housing scheme aimed at ensuring "Housing for All". The APAL team interacted with residents, listened to their concerns, and assessed the housing conditions of the families living in these colonies. Based on these interactions and site inspections, a preliminary list of eligible families is being compiled.

This list will be submitted to the relevant government authorities, ensuring that the identified families are included in the PMAY beneficiary list and can avail permanent housing. APAL's initiative reflects its continued commitment to uplifting the lives of people affected by leprosy, advocating for their rights, and ensuring access to basic needs like safe and dignified housing. This visit marks another important step in bridging the gap between marginalized communities and government support systems.

State committee recently met with Madam Sana Malik, Member of the Legislative Assembly (MLA) from Trombay, Mumbai, at her office.

On 7<sup>th</sup> April 2025, The State Committee of the Association of People Affected by Leprosy (APAL) in Maharashtra, in collaboration with the Maharashtra Kusht Pidit Sanghatana, has been actively working to highlight the concerns and challenges faced by people affected by leprosy in the state. As part of their advocacy efforts, the committee recently met with Madam Sana Malik, Member of the Legislative Assembly (MLA) from Trombay, Mumbai, at her office.

During this meeting, they submitted a formal memorandum addressing critical issues such as the rehabilitation of individuals living in leprosy colonies, access to government schemes, and the need for sustainable livelihood and educational opportunities for their children. The memorandum emphasized that 28 leprosy colonies in Maharashtra still lack access to railway services, while 2 colonies are situated within forest areas. Out of these, 23 colonies are on government land, and the committee requested the MLA's support in initiating land regularization and redevelopment efforts. The delegation also highlighted the need to include leprosy-affected individuals under the ₹6,000 per person Self-Employment Scheme, ensuring fair representation for those residing in independent colonies. Additionally, they urged for better access to quality education and higher education opportunities for children from these communities to ensure a more dignified and self-reliant future.

On 23<sup>rd</sup> April 2025, The Association of People Affected by Leprosy (APAL) continues to play a significant role in advocating for the rights, welfare, and health of individuals affected by leprosy across India. As part of its ongoing efforts to enhance outreach and service delivery, APAL's State Committee in Telangana recently met with the State Leprosy Officer, Dr. John Babu, at his office. The meeting focused on a critical issue that has long hindered effective leprosy control — the presence of hidden cases that remain undetected and unreported.

During the discussion, the APAL Telangana team emphasized the urgent need for a comprehensive re-survey across the state. They highlighted how updated and complete data would significantly improve strategic planning and the delivery of health services tailored to leprosy-affected individuals. Dr. John Babu responded positively to the concerns raised and acknowledged the importance of such an initiative. He expressed his willingness to collaborate closely with APAL and assured full support from the state health department. Dr. Babu also conveyed his appreciation for APAL's work and reiterated his commitment to

working together in a collaborative mode to achieve the shared goal of eliminating leprosy and addressing the needs of those affected.





Mr. Maniyada Ramesh, the State Coordinator of APAL Telangana, recently participated in a significant meeting at the office of the Director for Disabled Welfare

On 27<sup>th</sup> April 2025, The State Committee of APAL (Association of People Affected by Leprosy) in Telangana is actively engaged in addressing the pressing issues faced by persons affected by leprosy and individuals with disabilities across the state. As part of these ongoing efforts, Mr. Maniyada Ramesh, the State Coordinator of APAL Telangana, recently participated in a significant meeting at the office of the Director for Disabled Welfare. The meeting included the participation of various state-level leaders representing disability organisations, reflecting a collective commitment to improving the lives of vulnerable communities.

During the meeting, Mr. Ramesh brought attention to the critical challenges being faced by persons affected by leprosy in Telangana. He particularly emphasised the urgent need for the issuance of Unique Disability Identity (UDID) cards, access to housing schemes, and the provision of customised mobile footwear. He informed the officials that nearly 90% of persons affected by leprosy in the state are still awaiting their UDID cards, which are vital for availing of numerous government welfare schemes and entitlements. Mr. Ramesh earnestly requested the authorities to take immediate steps to resolve this long-standing issue.

The meeting was chaired by Director B. Shailaja and Chairman Veerayya, who attentively listened to the concerns raised and acknowledged the need for swift and effective solutions. The APAL State Committee remains hopeful that the Department of Disabled Welfare will act promptly to ensure that all eligible individuals affected by leprosy receive their UDID cards and other necessary support without further delay.
